On December 13, 2022, GVC Seattle Regional Center LLC (“the Regional Center”) filed a Form I-956 to request designation as a regional center under the Regional Center Program (the “Program”) in accordance with section 203(b)(5)(E) of the Immigration and Nationality Act (“INA”).

Effective as of the date of this notice, USCIS approves the Form I-956 and designates GVC Seattle Regional Center LLC as a regional center under the Program. The regional center designation is non-transferable.
